#### <u>Purpose</u>

This Program Memo provides funding information and specifies reporting requirements for your Supplemental Nutrition Assistance Program-Education (SNAP-Ed) Contract SP-1718, Amendment 1.

#### <u>Funding</u>

CDA is amending the SP-1718 contract to reflect the allocation of \$43,903 unspent federal funds identified in the SP-1617 contract closeout.

CDA will not process payments for SP-1718, Amendment 1 until the AAA's program Budget has been completed in the California Department of Social Services (CDSS) SNAP-Ed SharePoint site at <a href="https://snaped.dss.ca.gov">https://snaped.dss.ca.gov</a> and the contract amendment is fully executed.

## **Deadlines**

AAAs will have until February 26, 2018 to sign into the CDSS SNAP-Ed SharePoint to update their budget.

Monthly Expenditure Reports are due at the end of each following month. Expenditure time periods and closeout deadlines are footnoted on the Budget Display within Exhibit B of the contract.
