Hi, I lead a group of 3100 constituents and we introduced the concept of essential caregivers to Texas, were instrumental in the development of our emergency visitation guidelines and our statute as well as our constitutional amendment. Our emergency guidelines were comprehensive but we held biweekly meetings with our State Ombudsman, stakeholders, our long-term care regulation, and department of state health services to identify barriers to visitation. We tweaked those prior to adoption of our statute and development of permanent guidelines under that statute.
