10:04:05 Master Plan for aging likely you've all heard about it.

10:04:09 I hope you've read the plan and visited the website.

10:04:13 But because of this 5, this 10 year vision for building the most age and Disability, friendly state in the country.

10:04:21 We have been given and we're so grateful for it.

10:04:23 4.5 million dollars to launch a grant program to support local planning so Sort of replicate what we did at the State level, but make it more, more appropriate for your community is unique needs and assets so on the next line there, is an overview of how we develop the plan and I

10:04:43 Just want to focus on that this morning because that's really what this grant program is for it's for helping communities to develop their own action plan and so you'd likely would real replicate quite a bit of what we did.

10:04:55 At the State. So we had open a year of really intense stakeholder, and public engagement in order to collect input, and feedback, on how best to create

a master plan for our State, and we, did, that, through public participation in meetings, through surveys, and through many meany webinars we also

10:05:16 Had 4 stakeholder advisory Committees Comprised of People from all across California, who shared their expertise, and provided hundreds of recommendations to the Administration on How Best to Build Out this Master Plan and We also Hosted several Community Round Tables, with Legislatures, around the State, and very Importantly

10:05:37 We had a Cabinet Work group this Work Group is comprised of leaders from across the Governor's administration.

10:05:43 And so just like we did at the state with really aligning people across various sectors, and really gaining buy-in from legislatures, and partners, and state leaders you would likely have to do this at the local Level to execute a successful local age friendly plan in addition to this plan the Governor.

10:06:00 also called for us to build out a data dashboard for Aging, and a local playbook.

10:06:06 Now, I hope you all have had a chance to check out the local playbook.

10:06:10 It is available online, our next slide shows a few highlights of our local playbook.

10:06:16 How did we end up with these 5 old goals.

10:06:21 It was because of all that public and stakeholder, input so our master plan for is Comprised of these 5 bold goals housing for all ages and Stages, that also Includes not just Housing, but Accessible transportation, and in fact in emergency Preparedness, Health

10:06:38 Reimagined really covers aspects of Health, care, public health Alzheimer's and Dementia Goal, free Inclusion, and Equity, Not isolation.

10:06:48 This covers areas, such as cultural, competency, and language access but also prevention of elder and disability, abuse neglect, and exploitation as well as building out opportunities for true social engagement, really fulfilling Engagement, for people, throughout the entire course, of their Lives, we also built out this Goal.

10:07:10 Caregiving, that works which addresses, both Informal and Formal Caregiving, so that's the Direct Care Workforce, As Well as Friends and Family who are Caring for Loved Ones and Affording Aging Covers Topics, such as Preventing, Older Adult Homelessness, Ensuring Food, Security, and Protection, from

10:07:31 Poverty, alright, next slide, please

10:07:35 So the local playbook that I mentioned this is the cover page to it, we built this out over to 2 years ago, because the master plan was launched in January 1221 and it.

10:07:47 Launched with this local, playbook, and my Co. Presenter, today.

10:07:50 Jackie is actually refreshing this playbook over the next couple of months to add new resources, but go ahead, and check out.

10:07:55 The next slide please gives you a an idea of what it looks like.

10:07:59 You can go onto our website, we have a website just for the playbook and you can use all the resources, access, all the resources Via, our website or download, a copy, of it but we do have many re, updates, in and kind of a Refresh, happening, at the Moment so please check back on that Playbook.

10:08:19 Next slide. Please. Key component of not just the Playbook with the master plan is that we have a data dashboard, for aging and this is a fantastic resource for both State, and local, communities, it helps us, track, our Mpa progress toward our goals and it has nearly 4 Dozen.

10:08:37 Indicators at this point that come with visualizations.

10:08:40 But what I really like about it, the most right on the front page, is this Demographic Dashboard, and that's sort of what this slide pictures it is available at County level, and it's just a great way, for you to get a high level Snapshot of the demographics, within

10:08:57 Your county, when it comes to older adults, so it includes information.

10:09:03 Such as language spoken at Home and Education, Level Ages, race, Ethnicity, Income, and More. So so many valuable bits of demographics that you

can print out and bring to your local Leaders and Plans, and really zone in on what that older they'll Population, looks like in your County

10:09:23 Next slide. Please, so I'm gonna pass it over to Jackie Tompkins my colleague at the Department of Aging.

10:09:32 Jackie, is our master plan for Aging senior strategists, and is building out this program with me.

10:09:41 Yes, yes, I am thanks so amanda as Amanda shared the Budget Act of 2,022, did Allocate 4.5 million, dollars of one-time Funding, from our General, Fund for 3, years to the California, Department of Aging this is going to Enable Us, to provide.

10:09:59 Competitive grants to support support local jurisdictions, build out their own, Age and Disability Action Plans, we're seeking at this time, to Award up to \$125,000,.

10:10:11 Per jurisdiction for the total Project Period and seeking to award up to 36, jurisdictions with these funds next slide when we think about our Grant program, Priorities We're really centered on Equity Cultural competency as well, as community Engagement and meaningful

10:10:31 Engagement, activities. We're really seeking to support communities and populations that have been historically underserved and under-resourced and this includes smaller Population communities, rural communities tribal communities people from racial and ethnic minority, groups people with disabilities, and our

10:10:50 Lgbtq Communities.

10:10:53 We are currently built in the process of building. This grant program as well, as the request for applications in the speaking to release the Request for applications in early 2023, so at this time we want all of you to Share your knowledge Share your Experience, and Expertise with Us We do have a couple of we have a few questions

10:11:13 and prompts. As we go through the course of today's listening session.

10:11:17 And this is just an overview of the categories.

10:11:21 We have Amanda and I will be popcorn these questions.

10:11:25 So we can go back and forth, so we're really looking at areas, for you all, to tell us, what are some characteristics of an applying organization, that is helpful how do we work in equity, and cultural competency, principles.

- 10:13:44 a more, local level, their city, council, or their city mayor.
- 10:13:48 I think that's a great way to ensure support from the Leadership and to tie into other Community Initiatives.
- 10:13:56 Another idea is you know, having a established track record of Program Implementation and Managing Grants.
- 10:14:03 An Experience Gathering Community input Via surveys, town Halls, listening Sessions, Or Focus Groups, because as you mentioned with the Statewide Mpa, it was so important to get that community, input and local, input to Support the and then also kind of a nice to have I think is a
- 10:14:26 a track record of volunteer engagement, because so many of these age, friendly initiatives are really you know it's Not Just Kind of a top Down.
- 10:14:37 Approach but also Engaging Volunteers at the Community Level so I think that that would be another great characteristic
- 10:14:46 Thank you so much, Pauline. could we open up toy and all his line 10:14:54 We can, thanks.
- 10:14:54 Thank you. Can you hear me I aligned myself with the previous speakers, comments, and I'd also like to add that the organization
- 10:15:07 Master, Plan, for instance, our local organizations that have kept up with working and providing feedback, that now and the Master plan and also when we consider Grand Opportunities what have we tried that hasn't worked before you know, we should learn from our failures and Incorporate, why now
- 10:15:49 We, have some feedback in the chat, but I believe, that's all we have with live feedback.

10:16:00 Alright, our next, question Applies to the Characteristics of an applying organization.

10:16:07 What are characteristics of an applicant that demonstrates. They can facilitate chemistry, engagement to plan and develop a local age, and disability, friendly action, plan

10:16:39 Yes.

10:16:38 Can you hear me now perfect Just Building Off of What Pauline?

10:16:44 And has shared. I think that the applicant entity needs to demonstrate that they have the ability to go into very diverse communities within the region that this new aging and disability action plan would cover to recruit actual individuals to share their experience, the ability to hold focus groups conduct interviews.

10:17:14 And then to be able to synthesize that information, to ensure that they can appropriately capture the voice of those in their community, I think that would be quite important to be able to demonstrate

10:17:29 Thank you, Kelly.

10:17:35 Right. I see some more comments in our chat. But I think we can go on ahead and ask the third question, and Anytime, if you guys think of answers for previous questions, please, just enter into the chat.

10:17:54 So, looking at our third question this again, is also related to the characteristics, of an applying organization.

10:18:07 They have a commitment to implement and sustain a local age and disability-friendly action, plan

10:18:34 Okay, I think that it that is is one answer to me, and that would be a proven. Track record of service to the Disability and senior community.

10:18:52 Yeah, just to add, oh, just to ask to my comments.

10:18:58 Earlier, I think also support from the Agency's Leadership

10:19:01 I think so many times, we see one person driving an initiative, and then There's Staff Turnover or change in stuff.

10:19:08 And so I think, having you know, not only partnerships with other agencies, but also support within their own agency, from the top

10:19:22 Some comments coming in the Chat Recognized Board of Supervisors, buy in as well, as Other Key Implementation, Partners, identifying what has and included in the past and What has Worked Out what Else Do We have here, okay, Successful Community Partnerships

10:19:52 Long Term Partnerships with Community-based organizations, successful awards from multiple Funding sources to support development of new programs that lead to sustainable programs agree that buy in from the leadership is required, is there a couple of the comments in the chat and I see that

10:20:10 Carolyn Nava has raised her hand go ahead.

10:20:14 Carolyn She's Muted

10:20:19 Yes.

10:20:17 Good morning. Thank you. I think I'm on muted now perfect.

10:20:21 Oh, these are all great recommendations. It just do have one concern oftentimes.

10:20:43 Hmm, hmm.

10:20:29 There are definitely smaller agencies who don't have the history or impact that some of the larger organizations may have and the criteria is set so stringently that they cannot even apply and I think that really is something to factor in in the rural communities there are a lot of small agencies who have done.

10:20:51 Amazing Service, but they don't have the Grant history, background.

10:20:55 They don't have these high financial profiles, that some of the larger organizations coming through that will be applying.

10:21:06 Will bring to the table, and these are some of the Service organizations that we have been working with in the Northern counties, that are now saying how do we get a piece of this how do we show that for the last 2030 years we've already been doing this and the only thing that stops Us.

10:21:23 From doing more is access to funding

10:21:28 Thank you, Carolyn for your comments, and oh, feel

10:21:38 Can we unmute Ophelia. Oh, feeling, Sorry.

10:21:49 Yes.

10:21:44 Sorry I I think listed as hopefully. I know she's on the meeting as well I'm actually a colleague of hopefully and we I think I I very much agree with just the the previous comment that was mentioned and I wanna add to that that we've been

10:22:06 Recently talking about we've been looking at Grant Grants for older adults, and how to support that community and what we've been seeing is that a lot of the grant requirements, are requesting for innovative innovative ideas, and what we've been really having a discussion with and kind of

10:22:29 Grappling on this for based is that most often innovative ideas for rural communities like ours, is really to provide the basic needs for many of these communities, innovative for them, is like having Internet and some don't have Internet some don't.

10:22:51 Have transportation to get from their Rural Housing location to the nearest hospital, which is most likely an hour away.

10:23:02 So I I did it. I just joined in the meeting.

10:23:05 So I I'm not sure exactly what the requirements are.

10:23:09 For this grant opportunity. But I would like to express it. And just see how organizations, like ours, can be supported without really thinking of this these basic necessities for many of our older adults.

10:23:27 Thank you for your comments, Carolyn is your hand up again, or or okay, took it down.

10:23:34 Okay, We do have quite a few chats in the chat log.

10:23:42 Here, talking about the ability for more Established Agencies to partner with smaller agencies to for sustainable collaboration, applicants need to demonstrate collaboration with other Org City County agencies, community-based organizations Universities, Collaboration, Is Key Focusing

10:24:03 On underserved communities may need special considerations for Rural Applications, and I'd like to see that grant recipients have demonstrated experience with or a commitment deserving Adults with intellectual and developmental Disabilities many Policymakers believe that Adults, with

10:24:22 Idb are served by Dds. The Dvds only Serves, approximately, half of Adults, with Id and Carlyle Pacheco says, Some communities may have already been able to develop a plan or have made significant process through Investment, of Local Resources however, Implementation, and Sustaining

10:24:40 Progress is costly, the ability. To use these funds not only to develop a local playbook, but also implement those initiatives.

10:24:46 And monitor them over time would be valuable. wow!

10:24:50 So many comments coming in thank you, so much for all of this all of your input, here, we're saving this chat, log, we will bear all of this into consideration as we build out the request, for Applications, so we don't have a specific criteria, developed yet that's why we

10:25:07 have you here today to help us inform what is the Funding and eligibility criteria

10:25:15 Well, Tift.

10:26:18 This and have some contact information. Then we can talk amongst ourselves?

10:26:27 Just heard Carly Pacheco. She's in our service area, you know.

10:26:32 But there's also. You know, 50 other organizations in our service area.

10:26:36 So now I can follow up with Carly, but I don't know who else is listening in right?

10:26:42 So that's all

10:26:47 Diane Lawrence

10:26:56 Helps if I Unmute I just wanted to say that I think having an idea.

10:27:03 Who's on these, calls since so many people in the Chat have talked about mentoring and being able to to pair and and learning from others, Experiences, both positive and more challenging I think that Helps, build those Mentoring in that Collaboration, and where if there were the Possibility, to do some Sharing

10:27:28 Of Services or Sharing of information, especially in geographically, similar areas, that might, help the money be used more effectively in the community, and serve a broader population in the State

10:28:23 And I would just elevate that all the regional coalitions have current grant funding from the Scan Foundation to hold an event, around the Master plan for Aging which is certainly Connected to this Work Amanda so I would Encourage all the Organizations that if you are Part

10:28:39 Of a regional coalition. That you guys have a discussion about this opportunity to be thoughtful at as you move forward

10:28:49 Thanks. Kelly think Carolyn's hand is up again.

10:28:57 Yeah

10:28:56 Yes, thank you so much. Amanda and I'm just gonna follow Kelly, because I agree as the chair for one of those coalitions, that the Scan foundation has supported for many years we Are in deep Discussion, about this Offering and to be able to see who in our communities is actually on this call and

10:29:18 Interested would have been very, very helpful for us in the Follow-up.

10:29:23 We have meetings going on in collaboration and conjunction with this Rfp launch, that many of our coalition constituents are going to be reaching out for and it would be helpful for us to have some sort of platform to connect with each other post this conversation so that we can

10:29:46 Make sure that there is that true, if I can use these coin words, equity and inclusion, as these groups move forward.

10:29:54 Some of them are quite small and just don't have the resources are wherewithal to be able to even apply here so we've come to together as a coalition to say how can we make this happen for our community with some of these lesser known agencies that really are doing amazing work in

10:30:14 Our rural areas.

10:30:17 Thank you. Carolyn And thank you, thank you, everyone, for your comments.

10:30:21 We are going to move on to question number 4

10:30:27 Which is related to equity and cultural competency. what recommendations do.

10:30:34 You have for cda, to ensure that the Selected Grantees embed equity and cultural competency principles into the planning and development activities of their communities, local age and disability Friendly Action plan and the planet so

10:31:01 Caroline, did you raise your hand again.

10:31:05 Thank you.

10:31:08 It's Perfect Segue.

10:31:04 I did. This is just was a segue right into what so thank you, Amanda, one of the things that very clearly we run into as a rural region.

10:31:18 I'll be very frank here. Less than 2% of our population and a 26,000 square mile is composed of persons of color tribal nations.

10:31:31 Latino population, yet that is where the greatest requirement for these financial resources is falling.

10:31:39 And because there is such a small voice in comparison to the majority population.

10:31:47 They are often left behind, and I think that message is coming through from some of the individuals on the call today.

10:31:56 Our efforts with the coalition that Kelly, just ratioly mentioned, thank you for that Kelly, but our efforts with the coalition are very much focused on on that Population group, I'll give you just a brief example we recently as an independent living Center partnered with our brain

10:32:17 Injury, coalition, Locally, and the result of that partnering means that the brain Injury, coalition will now have the local Resources to reach out to the

African-american Senior Population to the Latino Senior population Getting More Resources out to where we really require them we want to do more

10:32:37 Of that, but again, these agencies are small, they're not gonna come to this table because they're intimidated by it.

10:32:46 So we're attempting to bridge that gap to make those links, so that the money can get where they're really required

10:32:55 Thanks Again, Caroline.

10:33:02 See, we have in the Chat Recommendations agency should be actively engaged in cultural humility.

10:33:09 Whoop! Just lost my Chat spot, keep cultural humility, training resources available for linkage and translation, services active engagement, with the Lgbtq, la, plus Community using local, listening, Sessions, to Engage Dei, and Track, same Valerie, Coleman, Stating, that this, is absolutely critical particularly

10:33:33 with regards to people with disabilities. Thank you for your comments

10:33:41 Anyone else want to raise their hand

10:33:48 Poly, Martinez

10:33:50 Sure I agree with you know all the comments we've had so far about a plan to capture community, input from Diverse perspectives, and just to add you know there's the diverse editions, sexual, orientation, agenda Identity, but also getting input from diverse

10:34:08 Caregivers, Adults with Disabilities and also Diverse Age groups, something that I I believe is important, not just like the young, old, but also the old, old people who are homebound, so really diversity, in many, different ways, and that can look different, you know could be via Surveys

10:34:25 Or town halls, or listening, sessions, or focus groups or phone interviews, so just being sure that you're capturing this diverse input.

10:34:36 Thanks. Pauling.

10:34:41 Well mentioning that in the chat that many of these populations overlap.

10:34:47 So I suggest intersectionality be addressed in the Application Process clay mentions that combating Agism and Ableism should be at the Forefront of Mpa Equity, and Cultural Competency, Efforts we have Comment from Marin rose about Building, Relationships Taking Time, and Consistency and

10:35:05 their success with native American Communities to providing infrastructure funding.

10:35:11 But more can definitely be done. great, thank you, Terry, for sharing a data resource in the Chat

10:35:30 Thanks amanda. So We're Gonna Switch Gears, a little bit and talk about funding, prioritization and some scoring incentives, so we wanted to hear from You on what Criteria, do you recommend Cva Use to prioritize the Funding, Selections under this Grant Program, to Support, Communities.

10:36:03 Rita, Saints, Hi, Rita.

10:36:09 Can you hear me now, okay, so one of the things that you know, with with all the people who have been doing.

10:36:21 This, historically, there, is a and and recognizing the need.

10:36:25 It would be our inclination to go to those organizations, one of the things that we might need to consider is an organization.

10:36:36 That works with these communities, historically, it has wanted to do.

10:36:42 Aging activities, but hasn't had the wherewithal to do it.

10:36:49 So there are 2 things, one, are we interested in these types of organizations, which have all of the yeah, how to do how to be in contact with your elected officials, they they do contact with their community they're very entrenched, in their community so but they haven't historically.

10:37:11 Done aging and disability. Work. So are we, saying, then that these people will not be considered or going back to the Scan, Regional, Groups important for people to reach out to communities.

10:37:27 To organizations. That have, historical oh, connection with these communities, and in include them in their application either as subcontractors, or as Partners, so that's the way a lot of community organizations in the past outside of the Aging Community have succeeded in developing cultural Content con cultural

10:37:52 Competence, by including the people who are used to working with these underserved organizations.

10:37:58 This thought.

10:38:03 Thanks Rita.

knock on to get services, and I would highly recommend in terms of prioritizing the funding selections that you must have a real clarity, about
