California Department of Aging (CDA)

California Department

Background & Purpose

- Labor shortage up to 3.2 million paid direct care workers
- Disproportionately large share of both paid and unpaid care provided by women; many are immigrants
- Direct care workers earn less than half of California's median annual income
- Low wages, stress, and an elevated risk of job-related injury reduce prospects for financial stability
- ²/₃ of older adults receive care from unpaid family and friends

The \$55 Million CalGrows Innovation Fund

- Award applicants a one-time grant
- Direct care worker (DCW) training and incentive programs
- Innovative ideas to address the common themes and challenges experienced by direct care workers and caregivers to family and friends

Applicant Eligibility Requirements

Who can Apply?

- Home and community-based providers and/or trade associations
- Direct care workforce training entities
- Community-based organizations
- Social enterprises
- Non-profits
- Adult education providers
- Others

- Presence in California within the last three years
- A single organization or on behalf of a consortia of organizations
- Be in good standing and qualified to conduct business in California as verified by the Secretary of State's website: <u>www.sos.ca.gov</u>

Applicant Eligibility Requirements

- Work with older adults, people with disabilities, and/or caregivers
- Manage and/or train the target direct care workforce
- Outreach to & engage the target direct care workforce
- Expertise on issues impacting older adults, people with disabilities, and caregivers
- A commitment to diversity, equity, and inclusion

Applicant Eligibility Requirements

Focus on Equity and Access

- Support the development of the culturally diverse workforce
- Provide culturally appropriate care to serve the diversity of California's older adults and individuals with disabilities
- Directly address barriers to access for training for the direct care workforce

Proof-of-Concept (Up to \$1 million)	Awards up to \$1 million to support pilots ready to be field-tested that seek to impact direct care workforce skills and retention.
Ready-to-Scale (More than \$1 million)	Awards for more than \$1 million to scale approaches that have shown potential to impact direct care workforce skills and retention.

Project Budget



- Maximum of 10% indirect costs
- No more than 50% of the budget should be for outside contractors or consultants
- Funding cannot be provided for a formal program evaluation
- Outline project personnel
- A budget narrative will be required





Request for Additional Information

- Letters of Support (maximum of two)
- References (maximum of three)
- Prior year financial statements (audited, if available)
- Operating budget (current year)
- Documentation and status of other related awards received

- All grant applications must be submitted through the online portal at <u>www.calgrows.org</u>
- If for any reason an organization cannot submit their application through the online portal, applicants must contact the CalGrows Innovation Fund at innovationfund@calgrows.org
- Applicants are encouraged to apply early, as all applications must be RECEIVED no later than 11:59 PM PST on December 2, 2022.
