Monthly Statistical Summary Report (MSSR) electronic submission process using the CDA Peach Provider Portal.

New MSSR Reporting Process

CBAS providers are required to submit the MSSR by the 10th of each month

for the previous month's data to the CDA CBAS Branch.

Effective June 10, 2019, CBAS providers shall submit the MSSR to the

CDA CBAS Branch electronically via the new Peach Provider Portal

internet-based application.

Data shall be directly entered in the MSSR fields within the application.

After all data has been entered, the CBAS provider shall send the data

electronically to the CDA CBAS Branch by clicking the "Submit" button

located at the bottom of the MSSR reporting screen.
