Purpose:

This Program Memo (PM) provides funding information and specifies reporting requirements for your Supplemental Nutrition Assistance Program- Education (SNAP-Ed) Contract SP-2021, Amendment 1.

Funding:

This contract amendment also reflects a carry-in amount of \$305,743 of federal funds from State Fiscal Year (SFY) 2019-20 to SFY 2020-21 based on SFY 19-20 SNAP-Ed closeouts.

<u>Allocation Methodology:</u>

For the SP-2021 Amendment 1 contract, due to Covid-19, CDA has waived the agreed upon carry-in allocation methodology between CDA and the C4A SNAP-Ed Allocation Workgroup. All AAAs have retained SFY 19-20 unspent funds. Any AAAs that had an unspent balance of more than \$1,000 will also not be penalized in the SFY 2021-22 contract.

Request for Funds and Expenditure Reports:

AAAs can request payments by submitting a completed SNAP-Ed Request for Reimbursement/ Expenditure Report (CDA 2001). For guidance on completing the report, refer to the SNAP-Ed Request for Reimbursement/Expenditure Report Instructions (CDA 2001i). These documents can be found on the <u>CDA website</u>.

CDA will not process payments for SP-2021 Amendment 1 carry-in funds until the AAA's program Budget has been completed in the California Department of Social Services (CDSS) SNAP-Ed SharePoint site and the contract amendment is fully executed.

Deadlines:

Monthly Expenditure Reports are due at the end of each following month. Expenditure time periods and closeout deadlines are footnoted on the Budget Display within Exhibit B of the contract.
