**Guidance** In the FY 2017-2018 SHIP Grant, ACL revised performance measures 2.1 through 2.7, eliminating two of the existing Measures and revising the remaining five.

The revised ACL performance measures will not impact the current Area Plan Update (APU), but CDA anticipates they will be included in the FY 2018- 2019 APU.

CDA is currently evaluating the five revised performance measures and will provide related guidance before July 1, 2017. CDA will update and post these new Measures as they become available.

GuidanceIn the interim, AAAs should refer to the Measures/Minimum Attainment ThresholdsContinued(MATs) communicated in PM 16-06 when completing the SFY 2017-2018 APU.
